# **President Ruto says devolved roles to be transferred to Counties**

resident William Ruto has warned of stern action against officials who misuse public resources.

He said as much as the Government continues to support devolution in transforming lives of Kenyans, he will not have mercy on those who misuse funds.

President Ruto called on the need for prudent use of resources to initiate more development projects aimed at empowering the lives of ordinary Kenyans.

"As far as I can tell, it was never the spirit or intent of the people of Kenya to devolve corruption, mismanagement and malpractices to the counties," said President Ruto.

The Head of State regretted that many counties have evolved into notorious epicentres of wanton looting, with everyone, from governors and county executive to junior officers being implicated in a wild free-for all at the expense of essential service delivery.

"Many innocent Kenyans are victimized, underserved or altogether neglected on a daily basis because of this devolved criminality," he said

He cautioned that counties must not become drivers of scandal, incubators of graft or embezzlement hubs, saying the people of Kenya deserve better, and they must be rid of 'this reckless betrayal'.

"It will not be business as usual. We must liberate devolution from corruption," he said.

President Ruto made it clear that corruption will be treated at all levels of government as a high priority law enforcement



issue requiring expeditious and decisive response.

"Regardless of position, office or other status, any person implicated in the loss of public funds, whether in the national or devolved government, must encounter the punitive consequences of their actions in full." said Dr Ruto.

He asked the agencies concerned to move with speed and attend to the many cases of corruption that are festering in many counties.

President Ruto, at the same time, said ditigitalisation and automation remain solution to poor governance and attainment of efficient service delivery.

"I therefore encourage you to embark on the journey of integrating digital solutions and ICT to service delivery and project implementation," said President Ruto.

The Head of State commended the many counties that have responded positively to his call of planting trees, as well as programmes and projects to restore depleted or degraded landscapes and ecosystems.

"Climate action and environmental conservations must be seen to be an integral component of transformation. It is also an opportunity for intergovernmental cooperation," said Dr Ruto.

Senate Speaker Amason Kingi urged counties to ensure accountable and transparent use of resources.

"It's time counties explore innovative ways of creating income generating projects to avoid over reliance on the national government," said Mr Kingi.

Prime Cabinet Secretary Musalia Mudavadi said devolution has impacted the society positively by transforming lives of ordinary

#### people.

"The only remaining focus is to tackle the problem of pending bills," said Mr Mudavadi.

Chairperson of the Council of Governors Anne Waiguru said devolution has transformed the lives of millions of Kenyans since its inception.

"As managers in our counties, we will endeavor to meet the aspirations of our people," said Ms Waiguru.

US Ambassador to Kenya Meg Whitman said Kenya was becoming the destination of choice for many because it's the most stable democracy in

#### the region.

She said last year's General Election was free and fair, having confirmed by the Supreme Court.

"What I witnessed was nothing short of remarkable. Kenya held what many analysts and commentators say was free, fairest and most credible election in Kenyan history," she said.

She said the country remains gateway to not only East Africa wealth but also Africa as a whole that need to be exploited.

Ms Whitman praised the ongoing efforts eliminate corruption in the country.

He said it was impressive that there were positive efforts in the fight against corruption in Kenva.

"President Ruto has introduced firm measures to eliminate corruption that has led to sacking of top Government officials involved in the vice," said Ms Whitman.

She noted that the kind of tertiary education in Kenya has made it possible for the country to have the best workforce in the world.

Chair of the Devolution Donor Working Group Amb Ole Thonke said Devolution in Kenya has become a game changer in transforming lives of the people.

He said the timely dispatch of money to counties by the national government remains key to efficient and prompt service delivery.

"The move by President Ruto and his administration to send funds to counties at the right time must be applauded," he said.

# Africa has a duty to make delibarate decisions to increase trade among its nations

resident Ruto said African countries should eliminate barriers to trade in order for investors to exploit opportunities in the continent. Speaking at the Joaquim Chissano International Conference Centre, Maputo, during the Mozambique-Kenya business investment forum, Dr Ruto said decisions must be made to promote intracontinental trade.

He argued that investors would not be able exploit the continent's potentiality if barriers hindering free movement of people and goods were not eliminated.

"There is no longer just a Mozambican or Kenyan market, because countries are now integrated in the Common Market for Eastern and Southern Africa (Comesa)," said President Ruto.

He added:"I want to persuade the businesspeople here to look beyond our two countries and explore opportunities in the continent."

He said there is the desire and aspiration that the continent should create a common market free from obstacles if 'we have to prosper'.

The Head of State reiterated



the need to empower Pan-African Parliament to make "We Africa Union (AU) accountable that

in its operations. "We must have a strong body that can be the continent's stand bearer on issues affecting the region," he said.

President Filipe Nyusi said there were opportunities for investments in the field of agro-processing, production of flowers and infrastructural development among other sectors. "We have improved our business environment for investments to thrive," said President Nyusi.

Meanwhile, President Ruto has assured Kenyans in diaspora that the Government will continue to carry out reforms aimed at improving service delivery.

He said efforts were being

made to ensure all Government services were moved to a digital flatform to enable them access services online without necessarily visiting offices.

"When I took over last year, 320 Government services were being done online. But now we've 5,300 services online. Am sure by the end of this year, all services will be done online," he said.

Addressing Kenyans living in Mozambique in Maputo, on Friday evening, Dr Ruto said the issue of driving licenses that has been a challenge to them in Mozambique has been resolved.

# **President Ruto** maintains the need for a barrier-free movement

emoval requirements among African states, remains key to promotion of free flow of people and trade in the continent.

William President Ruto maintains the need for a barrier-free movement of people and goods in the region.

He said there was need for African leaders to free the continent of border chains, noting that even 'those who colonized us have done away with visa requirements in their home countries'.

"Visa requirements, which were introduced by our friends, who created boundaries for us have abandoned it in their current locations. Surprisingly the European Union (EU) has a single visa among its 27 member countries," said President Ruto.

"But imagine, the people who created boundaries for us to have visa requirements, have abandoned the process in their home countries, simply because it has no meaning anymore. So, why should we continue implementing it?' asked President Ruto.

President Ruto said Kenva has lifted visa requirement for African countries to promote intra-continental trade.

He made the remarks on Thursday evening; during a banquet dinner hosted for



him at Ponta Vermelha Palace in Maputo, Mozambique by President Filipe Nyusi.

The Head of State is on a twoday state visit of the country.

At the same time. President Ruto, said the culture of violence should be discouraged

by all means. He emphasized on the need for African countries to embrace democratic ideals and desist from taking over power through undemocratic means.

"The same way we said no to colonialists who oppressed us, should be the same way we

to say no to those who want to take power through coups and undemocratic means in our African Continent." said President Ruto.

President Ruto said Kenva and Mozambique would continue to collaborate in areas of mutual interest for the benefit of their citizens.

President said Nyusi and Mozambique Kenya have strong bonds, noting that the people of the two countries have many common characteristics.

He called on the need for the two countries to enhance partnership aimed at uplifting the living standards of their people

"We will continue to improve our economic and diplomatic ties for the mutual benefit of our people. We want our citizens to take advantage of the existing opportunities to improve their lives in these two great nations," said President Nyusi.

the projects on time will be tolerated.

He argued that delays in roads constructions deny the country the much needed accessibility and faster movement of people and goods in the development

# **Five cybersecurity tips** suitable for everyday users

Passwords: Alwavs use complex passwords that are at least 12 characters long, combining uppercase, lowercase. numbers, and special symbols. Avoid using easily guessable information like birthdays or names. It's essential to have different passwords for each online account. Consider using a password manager to keep track of your passwords securely.

2-Enable Two-Factor Authentication (2FA): Activate 2FA on all accounts that offer it. This adds an extra layer of security by requiring two forms of identification before granting access. Even if a



hacker gets your password, they would still need another form of verification, such as a code sent to your phone, to access vour account. Phishing 3-Beware of

# Caring for the Earth as a Spiritual Practice

hen it comes to my relationship with the Earth. I sometimes ask, "Should I save it or savor it?" There's no doubt that Earth is in need of saving, and I know I have a role to play in reversing the damage we, as humans, have done to the Earth. Yet, I also feel a need to spend time just basking in the beauty of nature. I find that walking through a forest, hiking in the mountains, or just watching a sunset nourishes me in profoundly satisfying ways. I call such experiences "soulmaking" experiences; and by "soul-making," I mean that which helps to shape the core of who I am and gives my life deeper meaning.

But, then I ask, "With the environment in a state of crises and the future of humanity at risk, shouldn't our energies be spent on saving – versus savoring – the natural world? How can we be concerned about soul-making when there are much larger issues needing our immediate attention?"

Fortunately, the message about needing to "save the environment" is out there, and many are taking heed. What may be equally important, however, is a message about the need to save ourselves not just in terms of our physical well-being, but also in relation to our souls or spiritual wellbeing. If we need nature to nurture our souls, we'll certainly want to spend some time just savoring the beauty of the natural world. But does this mean that we have to choose between saving or savoring the environment? Is this really an either/or proposition? I think not. Working to save the environment is important for the health of the planet-and ultimately ourselves -- but such work can also promote the well-being of our psychics and our souls, especially when saving the environment is motivated by a sense of caring. Caring expands our souls

and is critical to attaining our full potential as humans. We sometimes refer to reaching our potential as achieving self-actualization which—as psychologists tell us-involves expanding our circle of concern beyond ourselves to include the larger community of humans. Aldo Leopold, in his articulation of "the land ethic," proposed an even larger circle of concern. He called for enlarging the boundaries of community "to include soils, waters, plants, and animals, or collectively: the land." Leopold believed that our relationship with nature should be based on an ethic of care versus coercion or fear. According to Leopold, this changes the role of humans from users and conquerors of the landcommunity to members and citizens of it.

When it comes to saving or savoring the environment, Leopold suggested that our ability to perceive beauty in the natural world may promote voluntary self-restraint for the sake of ecological sustainability. Taking this thought another step, it's reasonable to see how savoring the beauty of nature can motivate us to care for nature and that the very act of caring will nurture our souls and make us more whole.

We might pass mandates to save the environment, but will this approach save our psyches and our souls? For the we may need to focus-not iust on the environment—but on our emotional and spiritual connections with the natural world. Once we enter into a caring relationship with the natural environment and give of ourselves to protect it, we'll understand more fully the truth behind the sentiment that it's in giving that we receive. We'll also appreciate the fact that the land ethic isn't just a mandate or a code of conduct to be followed. It may prove to be a soul solution, as well. In this sense, caring for the earth becomes a spiritual practice and a path to spiritual growth. Both saving and savoring the environment thus become soul-making experiences.

# Kenya's unemployment paradox

recent times. the escalating unemployment rate in Kenva has sparked concern among analysts and conscientious citizens alike. The ramifications of this arowing issue, including surge in rural-urban the migration, an upswing in mortality rates, a surge in criminal activities, brain drain, the rise of prostitution and child trafficking, increased psychiatric admissions to hospitals, reduced payroll tax contributions, and even the emergence of insurgency, have woven themselves into the very fabric of Kenyan society.

As this complex problem festers, a plethora of solutions have been proposed at various Among junctures. these suggestions are streamlining the civil service, implementing an effective family planning system, bolstering youth empowerment initiatives. providing enhanced support to small and mediumsized enterprises (SMEs) promoting agricultural mechanisation, nurturing development industrial and infrastructure, refining school curricula to emphasize practical skills, achieving a

harmonious blend of local and expatriate labour in contracting work, and fostering a spirit of self-discovery and creativity among the nation's youth.

However. а closer examination reveals а counterintuitive reality - a shortage of skilled workers. One can't help but ponder why a nation with a police force numbering less than 250,000 officers tasked with safeguarding a populace of approximately 60 million is grappling with unemployment. This situation, it appears, is a puzzle that could be addressed by redeploying just a fraction of those police personnel into sectors facing manpower shortages. Even though Kenya is home to a large pool unemployed graduates, of particularly those with degrees in education and related fields, the education sector still cries out for a stronger numerical force of teachers.

Remarkably, over 7.000 Kenyan doctors have sought employment abroad, with many seeking opportunities in Europe, Saudi Arabia. and beyond. This puzzling trend reveals а aapina disparity - while we lament the shortage of doctors in Kenyan hospitals, a substantial number of qualified medical

professionals from the country are contributing to healthcare systems elsewhere. Such a paradox!

In view of these alarming contradictions, the onus falls on various tiers of government to act promptly and resolve this paradox. The repercussions of inaction are already gnawing at the foundations of the national economy. In the face of such an imperative, it is only fitting for Kenyan society to channel its energy into addressing this challenge head-on. After all, it is in the darkest of hours that the brightest solutions are often conceived.





# Russia's war in Ukraine sponsors more renewable energies for Europe

o date, Vladimir Putin, the Russian leader, has managed to unify both NATO and Europe in their combined stance to oppose his blatant aggression and misguided thinking. The war has resulted in massively increased defence spending by the West, and a total change in direction for Germany, along with Sweden and Finland joining the NATO fraternity.

This outcome must be the very opposite to Putin's aims, when he invaded Ukraine in early 2022, hoping to pull the errant nation back into the Russian fold. It had worked pretty well in 2014, with Crimea, as the West turned a blind eye, so why not the whole of the country?

Another result of the war has been to galvanise European resolve to move as rapidly as possible away from fossil fuels, towards renewable energies, such as those generated from hydro, solar, wind, wave, and geothermal sources. Nuclear has come back into the mix for some countries, as (even with inherent risks) it can offer a preferred option to oil and gas. The sudden reduction of fuel imports from Russia has underpinned this more rapid transition to alternative energies, with the main aim of achieving carbon emission reductions. to support ambitious climate objectives, over the next twenty-five years.

I predicted these changes to Europe's energy strategy in an earlier column ('Putin's Ukraine war could mean more Sustainable Change') written soon after the war began. At the time, it was a blinkered attempt to put some positive spin on the war, where all seemed hopelessly negative. But now, a year or so later this move to alternative energies by Europe as a massive economic block, has become reality, and is gaining traction.

Energy from renewables across the 27-member European Union, currently stands at 22% (encompassing a wide range from 13% in Ireland to 63% in Sweden); with energy generated from biomass forming the largest part of the mix. But to achieve energy security while meeting carbon goals, the EU needs to accelerate its transition to areen energy, to meet targets of 55% reduction of carbon emissions by 2030, and netzero by 2050. Within these overall goals, the 2030 target for renewables was recently increased from 40% to 45% in response to the Russian invasion, and is particularly dependent on increaseing offshore wind and rooftop solar. European climate chief Frans Timmermans stated: "Russia's weaponising of energy has reinforced our transition to renewables."


Thus, the invasion of Ukraine has unified Europe more than ever before, in a common goal of severing energy supply ties with Russia, whilst holding to commitments on climate related goals. Launched in April 2022, the EU Energy Platform is a good example of this, while their Common Gas Procurement Policy has utilised the leverage of the block to enable natural gas security that surpasses total needs. The road ahead is steep ... and expensive: the EU predicts a further 113 billion euros investment in renewables will be required by 2030, to completely end reliance on Russian fossil fuels.


Holding the line to current climate commitments, made initially at the 2015 UN Paris Agreement, hasn't been easy, because of the unanticipated onslaughts of the coronavirus pandemic. followed immediately by Ukraine, both having a negative impact on macro-economics, particularly in areas of Health and Defence spending. As we know, 'Money doesn't grow on trees': if we spend on Covid vaccines and leopard tanks, costs will spiral, resulting in mounting debt and looming recession, which to some degree has happened.

A major factor contributing to EU net-zero will be electrical energy generation, for home, for industry and for transport. Currently renewables account for 37.5% of gross energy

consumption to produce electricity, led by wind (36%) and hydro-power (33%). The transport sector is moving rapidly towards Electrical Vehicles with Scandinavian countries leading the way (again Sweden is in the lead with 34% of its transport powered by renewables). Hydrogen – preferably the 'green' variety developed from renewables – could also be a major contributor, suited to powering larger transport systems, such as trains, buses and ships.

Nuclear power generation is a complex issue. Some countries have, and still do utilise nuclear as a major power source, but because of risks related to disposal of radioactive waste. and potential for disaster (a la Chernobyl or Fukushima) most had been moving away from this option. Now, Ukraine fosters a greater need to consider all alternatives. in order to fill the void left by lack of oil and gas from Russia. Strictly speaking, nuclear energy is not renewable, as the power source is uranium, an exhaustible mineral.

In many ways the EU is leading the way, but it does need to remain on track. providing the shining light for others to follow, if the targets for 2050 are to be realised from a global standpoint, and the climate crisis is to be met headon, limiting global heating to 1.5 degrees Celcius. But even on the periphery of the EU, the UK appears to be wavering, and major polluters USA and China, lag behind the pack. Within the EU block, the rise of the far right poses a problem, with a tendency towards climate denial and ambitions to turn the clock back to use of fossil fuels, in support of a 20th Century-style marketplace.

For me, as a writer who has been involved in education for vouth related to sustainable change over the past 30 years, it seems to be an irrefutable logic that climate change presents the most severe threat to life as we know it, on earth: the greatest challenge to civilisation since homo sapiens first roamed the African plains! Now thirty years after I began my own small works, there are unprecedented heat waves in Europe, forest fires rage across Australia, floods inundate Pakistan, and the Horn of Africa faces its most severe drought in forty years. More than that, the less direct impacts of climate change, such as intra and intercountry conflicts, terrorism, and refugee crises, we see having an increasing impact around the globe, and visible on a daily basis across our news networks

So, just as many plant and

animal species are feeling the negative effects of global heating, it should also be entirely obvious to humans after all we tend to think we have superior brainpower that urgent action is required to remedy this self-inflicted crisis. The world of science is unified in its opinion that humankind caused the problem, in particular by exploiting the use of fossil fuels to power the industrial age, so it should be humankind that is responsible for fixing it! After all we can't rely on chimpanzees or crocodiles to lead any concerted push for remedial action. It's also interesting to note that there's little contrition on the part of Big Oil (Exxon, Shell, BP, and others) for the problems caused (and which they had clear knowledge of about fifty years ago); just as there tends to be little remorse on behalf of British American Tobacco for their contribution to lung cancer

So, who does the fixing; not leopards or lions, obviously, and most likely not the market place on a voluntary basis either. It has to be a joint effort on behalf of governments and civil society, working in partnership with private industry, to produce the necessary seismic shift in thinking, and rally behind strong resolute leaders, who then take our global society in a new direction. This will be quite a challenge, as neither the market-driven democracies of the West. nor the various autocracies. are particularly well suited to delivering solutions based purely environmental on or social needs, rather than economic goals: it doesn't fit the model of two-party, or multi-party goals, which have a tendency to resort to partypolitical and partisan gain, regardless of the outcome. For the future of our planet, it is becoming increasingly obvious that we need to put short-term political gains behind us, and join together in fixing the longterm problem, which is looking more and more apocalyptic with each successive news broadcast!

# Let us talk about blood pressure – the silent killer

lood pressure refers to the pressure exerted by circulating blood against the walls of blood vessels. It primarily originates from the heart's pumping action as it propels blood through the circulatory system. When used without gualification, "blood pressure," we are referring to the pressure measured in the brachial artery.

High blood pressure, or hypertension, is a common condition that impacts arteries. In this condition, the force of blood against artery walls is persistently elevated. causing the heart to work harder in pumping blood.


Blood pressure is measured in millimeters of mercury (mm Hg). Hypertension is typically defined as a reading of 130/80 mm Hg or higher.

The American College of Cardiology and the American Heart Association classify blood pressure into four categories. The categories are as follows:

1. Normal blood pressure: 120/80 mm Hg or lower.

2. Elevated blood pressure: Top number between 120 and 129 mm Hg, and bottom number below 80 mm Hg.





Stroke: Occurs when high blood pressure leads to the bursting or blockage of blood vessels supplying oxygen to the brain. As a result, the affected part of the brain, deprived of oxygen, begins to undergo damage and cell death.

Heart Attack: High blood pressure damages arteries, making them susceptible to blockage by fats and cholesterol. The narrowing and hardening of arteries increase the likelihood of blood clots, which impede the flow of oxygen and nutrients to the heart.

Heart Failure: High blood pressure places added strain on the heart, causing it to work harder. Over time, this increased physical stress results in the heart thickening and enlarging, making it more challenging to efficiently pump blood throughout the body.

Kidney Failure: High blood pressure can harm the arteries surrounding the kidneys, diminishing their ability to effectively filter waste from the blood. It is the second leading cause of kidney failure, surpassed only by diabetes.

Lower Sex Drive: Sexual organs require increased blood flow. Men may encounter difficulties in achieving and sustaining an erection, while women may experience a decrease in sexual desire.

3. Stage 1 hypertension: Top number between 130 and 139 mm Hg, or bottom number between 80 and 89 mm Hg.

4. Stage 2 hypertension: Top number of 140 mm Hg or higher, or bottom number of 90 mm Hg or higher.

Untreated high blood pressure raises the risk of heart attack, stroke, and other severe health issues. Regular blood pressure checks, at least every two years from age 18, are crucial. Some people may require more frequent monitoring.

Healthy lifestyle habits, including abstaining from smoking, regular exercise, and a balanced diet, can aid in the prevention and management of high blood pressure. Medication may be necessary for some people to treat high blood pressure.

High blood pressure often goes unnoticed as it silently causes gradual damage over time, without noticeable However, symptoms. it significantly increases the risk of developing life-changing and potentially life-threatening medical conditions.

Hand surgery

Teaching and Referral Hospital Successfully Rejoins an Amputated Limb Following a Domestic Assault in an 11-Hour Surgery.

The 35 years old male patient identified as BK was rushed to the Moi Teaching and Referral Hospital on 8th August 2023 with his left hand traumatically amputated after being referred from Sigowet Sub County Hospital.

While arriving at the Moi Teaching and Referral, the amputated hand was preserved in a coolbox, and within 15 minutes, the patient



had been rushed to the theatre room

At the theatre, two teams

worked alternately to stabilize the patients and reverse the amputation. As one team worked on reattaching the left hand, the other team was working on restoring blood flow to the amputated hand, revascularization.

The reimplanting and revascularization surgery was successfully completed at 3AM after 11 hours of concerted efforts to restore BK's left hand.

BK was then moved to postanesthesia care unit and later on to the ICU for monitoring. He was also intravenously infused with Heparin to prevent blood clotting.

On Thursday, the patient's limb was splinted and the rehabilitation process was initiated.

At the time of publishing this article, the patient had been moved from the Intensive Care Unit to the General Orthopedics Ward where he is closely being monitored.

A Doppler Ultrasound scan has also revealed that the revascularization process was successful and blood flow in the main arteries and veins of the reimplanted arm is good.

The reimplanting of the left hand of Mr. BK was successfully led by a team of doctors and nurses including Dr. Brian Christie, Dr. Paul Mwangi, Dr. Andrew Vernadi, Dr. Gregory Wekesa, Dr. Harsh Vadgama, Nehemiah Nyainda, Roise Keino, Caren Cherotich, Oscar Ang'anda and Ezra Samoita.
